Proposals:

Due to the importance of satisfying accounting protocols, Sr. Debbie suggested that the NW Area Vocation/Formation group consider depositing the current funds with the NRVC treasurer. These funds would be accessible to the area members at any time.

Sr. Debbie noted that the NRVC National Office provides an annual subsidy of \$1000 to cover the expenses of a speaker's stipend, housing, and transportation.

Motion: Sr. Sheila moved, and Sr. Anna seconded the proposal that the NRVC/RFC regional funds be transferred to the NRVC National Office after the expenses of this meeting (April 30-May 2, 2024) are paid. The motion passed unanimously.

Motion: Since speaker fees will be covered by the NRVC National office (odd-numbered years) and the RFC local directors could charge a fee for speakers to all those who participate (even-numbered years), Sr. Teresa moved, and Sr. Chero seconded the proposal that member area dues will no longer be charged beginning in 2025. The motion passed unanimously.

Sr. Chero presented information about the opportunity for our member area to become a sponsor of the 2024 NRVC Convocation. The fee of \$500 would be considered an expense of this meeting and be paid prior to closing the local financial account for this member area.

Motion: Sr. Sheila moved, and Sr. Paz seconded the motion that our member area become a \$500 Diamond Lake sponsor for the NRVC Convocation in November 2024. The motion passed unanimously.

Treasurer and Secretary

Sr. Patricia will follow up on payment of the expenses of this meeting and arrange for a check to be issued to NRVC for "safekeeping." She will need to continue to report on these funds held by NRVC. Sr. Charlene agreed to serve as secretary for another year.
